
people to vote. The Voter ID law only disenfranchises those groups even further. I hope you have a safe and happy holiday season. Happy 2012!

As 2011 comes to an end I can't help but reflect on the changes we have seen in the last year. While the Voter ID law has created a significant amount of attention and consternation, there have been a number of other issues that have affected us including mining legislation, privatization, education, and health care. At times it is difficult to keep up with all of the decisions that are being made and it's a reminder we have to remain vigilant and do everything we can to maintain the rights so many have worked toward.

Locally, the Observer Corps, the excellent programs, the Hmong Mutual Assistance Association election, and determining the most effective means to help people obtain a Voter ID laws have kept League members busy trying to figure out how we can continue to be relevant and effective in the community. 2012 brings a significant challenge to the membership to continue to use our voices to uphold the basic rights. The Non-Profit Voter site noted the following: 24% of youth (ages 18-29) turned out in 2010, a sharp drop from 51.1% in 2008. There was a 20 point turnout gap between members of lower income and higher income households. Only 35% of those with a high school diploma or less turned out in 2010, compared to 61% of those with a college degree or more. We have to do whatever we can to help motivate

## ***Privatization of Government Services and Compatibility with Democracy***

Privatization is a worldwide phenomenon. In recent years, public-private partnerships have become a regular tool for national, state, and local governments to more conveniently fulfill their duties. All levels of government, seeking to reduce costs, have begun turning to the private sector to provide some of the services that are ordinarily provided by government. By involving groups from the private sector, governments have tried to improve the way they perform their duties, especially concerning infrastructure improvement projects. Governments have transferred over design, construction, operation, and maintenance responsibilities to the private sector based on the belief that the private sector can fill these needs more efficiently than the government could. Governments are also leasing or selling established government assets, such as toll roads or loan portfolios, in exchange for upfront cash payments. These moneys are used towards new projects or put towards other government needs. The spread of the privatization movement is grounded in the fundamental belief that market competition in the private sector is a more efficient way to provide these services and allows for greater citizen choice. In practice, however, concerns about service quality, social equity, transparency, and employment conditions raise skepticism of privatization. Is Privatization in the Public's Interest?

The League of Women Voters on the national level has already begun a study to look into Privatization. The study will focus on the impact of privatizing government services on local communities. It will review the community impact

of such transfers, and identify strategies to ensure transparency, accountability, and preservation of the common good. In January there will be posted consensus questions regarding the issue based on the National Leagues previous work. The La Crosse area League of Women Voters will also be studying the issue. We will respond to the consensus questions based out of the National League's study. We will have until May to study and respond to the issue from our perspective. To celebrate and kick-off the Privatization Study for La Crosse's community, Jack Norman, director of research, for the Institute for Wisconsin's Future (IWF) will come to La Crosse to hold two informational meetings. He will present to policy makers, elected officials and the community at large on Monday, January 23, 2012 at 11:45 am, at the La Crosse County Health and Human Services Building, 400 4<sup>th</sup> St. La Crosse, in the basement auditorium and then he will present again at 6:30 pm. at UW-La Crosse, Port O' Call room.

Jack will be defining privatization, describing different forms of privatization, sharing examples, and discussing the impact of privatization on the Public Interest.

The panel will feature Dr. Karl Nollenberger of UW-Oshkosh; Wisconsin City/County Manager Association "Range Rider" Ed Madere; and Beaver Dam Mayor Tom Kennedy. La Crosse County Administrator, Steve O'Malley will moderate the discussion.

Dr. Karl Nollenberger is an accomplished practitioner in public administration. He served 30 years in local government positions in city and (*February Program, continued page 3*)

county management in five states as well as in financial management in local government. Dr. Nollenberger served as President of the International City/County Management Association. In addition, he is a Fellow in the congressionally chartered National Academy of Public Administration. Professor Nollenberger received his Ph.D. from the University of Chicago in 2008.

Ed Madere offers his professional expertise and experience through the Wisconsin City/County Manager Association's Range Rider Program. The Range Rider Program provides counsel, experienced perspectives and support to Wisconsin cities and counties' elected officials, staff as well as community organizations. Recently, Madere served as interim city administrator for Waupun as it hired a full-time administrator.

Beaver Dam Mayor Tom Kennedy has served as mayor of that city for two terms. He will be seeking his third term as mayor in April.

Currently, the City of La Crosse is preparing for a referendum on proposed legislation to create the position, duties and responsibilities of the Office of City Administrator to compliment the work of the Mayor and City Council. This La Crosse League of Women Voters' program promises to provide perspectives, and explanations regarding the potential benefits and downsides to the legislation.

In the referendum, La Crosse residents are asked to decide whether or not creating the position of City Administrator will complement the office of mayor and be accountable to the city council. City voters will weigh the costs, benefits and accountability questions in the municipal spring elections.

All members of the community are invited to attend to learn more. There is no cost for the program. Lunch will be available given reservations, which can be made by calling Nancy Hill, 608-782-1753, by February 10. Cost for lunch is \$12.00.

### ***December Program Review***

State Representative Sondy Pope Roberts, the ranking member of the Wisconsin Education Committee and Jim Bender, the President of School Choice Wisconsin, presented two starkly different versions of the topic at the December LWV program meeting.

State Representative Roberts refused to call the program by its name, *Parental School Choice*. Rather she called it the Voucher Program and presented it as a move to destroy Public Education and to implement privatization of education. Representative Roberts stated that public funds pay for 83% of the students enrolled in the voucher schools.

Jim Bender, President of the organization *School Choice Wisconsin*, a privately funded group, presented the program as an alternative to poor public schools. He also mentioned that the cost for educating students in the Choice Program is about half that of the Public School system.

The Milwaukee voucher program has been in place for 20 years. This year the program was expanded to the Milwaukee suburbs and to Racine, and the enrollment caps and income requirements were raised. There was an effort to expand the program to other areas of the state and to eliminate the set income level requirements for parents who participate in the voucher program. Although there are some voucher schools that have done well, the overall success rate of the schools is comparable to low income Milwaukee Public School students. Part of the cost of the voucher program is paid by Milwaukee property tax payers. Voucher schools are exempt from many of the regulations that are in place for public schools such as requirements for appropriate programming and services for Exceptional Education students.
