## EDUCATION IN THE TWENTY-FIRST CENTURY

Kathy Tyser, Retired Associate Superintendent of Instruction for the La Crosse School District

The speakers initially looked at where education has come. Kathy mentioned that when she first started teaching in 1972 the federal law mandating special education for certain students had just started, and prior thereto many children in need of special education were institutionalized. The range of special needs in children is great. She reflected that graduation rates now are higher than they have ever been. The stated goal of 100% graduation isn't necessarily realistic. High school graduation rates in our grandparents' times were much less. Also, compulsory school attendance has increased from age 16 to age 18, and she noted that it is much harder to keep older students in school and motivated. She noted that we have a very changing population of students in school. Also, there has been more teacher specialization and more educational certificates, from special education, gifted and talented, English as a second language, physical education and so forth. Currently, many rural areas are not able to find teachers with the correct certifications to teach in all the areas. Schools are also looking at different ways to deliver instruction including extending the school day, starting children at younger ages, summer school and after school programs.

Kathy also noted that there are many more issues dealing with students' behavior, safety and security of the building, medically fragile students, and emotional issues. All schools are required to have safety plans. In addition, unfunded mandates continue to be a problem in that there is not enough money to pay for everything. The federal government has never funded special education to the extent that it was originally promised. She also noted how we now have more options such as school choice, charter schools and specialty programs. Also, there has been a movement away from local control and more to state and federal control, along with state and federal funding. The "No Child Left Behind" law is the law that provides for the most federal involvement in schools that we have had to date. This law requires mandatory testing at different times during the educational life of the student.

Mandatory testing, Sandy and Kathy noted, is not necessarily consistent with the trends in learning, including more problem-solving strategies and skills for critical thinking, making decisions in collaborative groups which are all hard to test and conflict with the current testing requirements. There's also literature that suggests that the use of significant technology in learning may actually be changing how students' brains continue to develop.

The other major concern at this time is funding of education. There's been a discussion about the 3-legged stool for state funding: the state funding amount, the revenue caps and the QEO which limits the increase that can be paid for teachers' salaries. Those issues are now in flux.


The No Child Left Behind Act seems to require all children to be treated the same, from special education to the gifted and talented. Learners who do not have English as their first language are required to take the test in English after they have been in the country one year. (Think about taking a test in Russian or Vietnamese after being in that country one year.)

Every state sets its own standards and assessments, so a state could set a very easy standard and not fail on the No Child Left Behind. States that want to have decent meaningful standards have a harder time to meet the bar for all children. Also, setting up standardized tests is very expensive and there's no way to compare across state to state. Should there be a national test? The No Child Left Behind seems to be more of a one-size fits all piece of legislation. The opinion of the presenters was that such a piece of legislation does not really fit well in a large country with so many different children along the entire spectrum.
