#### **VOTING IN WISCONSIN**

#### **Qualifications:**

U.S. citizenship, 18 years of age by Election Day, residence in Wisconsin and your voting ward/district for at least 10 days prior to Election Day are required. Residence in a ward/district for fewer than 10 days, but immediately preceded by residence elsewhere in Wisconsin, allows an elector to vote in the former ward/district by absentee ballot. Absentee ballots are available at each municipal clerk's office. For additional information on voting in Wisconsin, please contact your local municipal clerk, the LWVWI website at http://www.lwvwi.org/, or the State Elections Board website at http://elections.state.wi.us/.

#### **Last Minute Voter Registration:**

Registration is required in most municipalities; check with your municipal clerk. The deadline for mail-in registration in most municipalities is 5:00 p.m. the 2<sup>nd</sup> Wednesday before the election – Oct 20 for the Fall 2004 General Election. You can also register in person at the clerk's office (up to the day before the election) or at the polls on Election Day. Acceptable proof of residence is required, such as a driver's license or identification card with your current and complete name and address. If you do not have proof, a qualified voter from your municipality can serve as your witness to verify your address. This corroborator must then provide acceptable proof of residence.

# **United States Congress**

# U.S. CONGRESS

#### About the U.S. Congress

Comprised of the Senate and the House of Representatives, the U.S. Congress is responsible for making laws for the country. It has legislative power to spend and tax in order to provide for the common defense and promote the general welfare of the citizenry. Congress has the power to borrow money; power to regulate commerce with foreign nations and among the states; power to declare war, raise and support armed forces; power to establish post offices; power to set up federal courts under the Supreme Court. Congress participates in the process of constitutional amendment. The Senate confirms Presidential nominations and must consent before a President may ratify a treaty. Members of both the House and Senate attend to constituents' requests and problems with the government.

Each state elects two senators who represent the whole state. They are elected for 6-year terms.

The House of Representatives has 435 members who are elected from districts within the states. Members of the House serve 2-year terms. The congressional salary is \$141,300 per year.

- 1. What specific economic policies are you going to champion to promote educational, occupational, civic, and community experience that you believe qualifies you for this office?
- 2. Should the United States build protections for working conditions and the environment into international trade agreements?
- 3. These are challenging times for all Americans. While there are real and serious terrorist threats, it is important that we preserve the greatest degree of civil liberty in the fight against terrorism. Do you believe that the USA Patriot Act strikes the appropriate balance between ensuring homeland security and preserving individual liberties? Why or Why not?

1. I will continue to fight to ensure that our future trade agreements keep jobs in Wisconsin and help Wisconsin businesses compete. Second, I will continue to work to expand access to higher education by increasing the size and number of Pell grants, to give more people access to the foundation they need to launch their careers. I will also continue to promote my comprehensive proposal to provide quality health care for all Americans. This proposal will help relieve the burden of health care costs on employers and will encourage the creation of well-paying jobs.

- 2. Yes, trade agreements should protect working conditions and the environment, and I have introduced legislation to establish minimum standards for future trade agreements. My bill calls for enforceable worker protections and requires that trade agreements contain environmental provisions subject to the same enforcement as commercial provisions. I voted against NAFTA, GATT, Fast Track, and Most Favored Nation status for China because these agreements lacked such standards and because I believed they would cause Wisconsin to lose jobs. Unfortunately, I was right: Wisconsin has lost thousands of jobs because of these agreements.
- **3.** I was the only Senator who voted against the USA Patriot Act. I supported 90% of the Act's provisions that gave law enforcement the tools to prevent future terrorist attacks, including expanding access to roving wiretap warrants. But the Act did not provide sufficient protections for innocent Americans who have absolutely no connection whatsoever to terrorists. I joined with a bipartisan group of Senators to introduce the SAFE Act which would fix many of the USA PATRIOT Act's most troubling provisions."

In all the positions I have held, leadership skills were required. In industry, I learned it's results that count. At SSI Technologies, I learned to work as part of a team, so my company could prosper. I will work as part of the House of Representatives team to produce results on the issues important to all Americans

- 1.We must increase our investment in new technologies to create good jobs. The \$7 trillion we owe in national debt, growing by over \$400 billion dollars per year, is draining away the money that should be invested in American industries. Much of this debt is owned by banks in China and Japan that use our interest dollars to invest in their industries taking away more of our jobs. I will reestablish the pay as you go rules that led to our 1999 surplus. This will reduce our debt, and stimulate investment to create jobs in America for Americans.
- 2. Working conditions and environmental issues are best covered with agreements other than individual trade agreements. A good example would be the Kyoto protocol. This protocol is perhaps the most important environmental treaty in the world today. Unfortunately, the United States has not chosen to join the majority of other countries in the world that have signed onto the accord. We must be a cooperating member of the world community if we expect to make progress on global issues. I will introduce and support legislation to accomplish this goal.
- 3. There are portions of the Patriot Act that clearly violate our civil liberties, e.g. the acts provision allowing authorities to obtain information concerning a citizens reading habits. People are being held, without charge, oftentimes for years, without adequate recourse to defend themselves or seek justice. This is a clear violation of our constitution. We must not endanger our liberties unnecessarily just because of the threat from terrorists, otherwise they will have partially succeeded on one of their objectives. Fighting the war on terrorism requires we not only keep our eye on the terrorists, but also our Constitution.

Tammy Baldwin began her service in Congress in 1998, becoming the first woman to serve from Wisconsin. Congresswoman Baldwin serves on the Budget and Judiciary Committees. She is a leading advocate for health care for all, protecting Social Security and Medicare, providing a real prescription drug plan for seniors, supporting our veterans, creating well-paying jobs, and increasing support for public education including financial aid for higher education. Raised by her grandparents, Tammy is a life-long resident of south central Wisconsin. She graduated from Madison West, Smith College, and UW-Law School. She practiced law in a small firm until 1992.

- 1. The creation and retention of well-paying jobs is one of my highest priorities. I support incentives for companies to keep jobs in the U.S. I also support investing in our nation's infrastructure, including our transportation systems, which will create many family-supporting jobs. New Department of Labor rules, which I strongly oppose, may end overtime pay for six million Americans. I oppose "free trade agreements," like NAFTA, and special tax breaks which encourage companies to outsource jobs to foreign countries. Our armed forces and federal government should "buy American," and I have been a leader in that effort.
- **2.** Yes, absolutely. I support fair trade. Our current trade agreements do not include adequate labor, human rights, or environmental standards. When countries such as China ignore worker protections and pay wages that keep people in poverty, production costs less and this puts American workers at a significant disadvantage. It used to be that well-paying technical and highly-skilled service jobs

were protected from being sent to foreign countries. That is no longer the case. I work hard to keep good jobs here in America. We should insist on adequate environmental standards. Environmental degradation affects us all.

**3.** No. As we work to prevent terrorism, we must fervently protect American lives while protecting the American way of life. As a Judiciary Committee member, I played an active role in the debate, and was pleased to be a part of the bipartisan Committee effort to rewrite Attorney General Ashcroft's first proposal. Unfortunately, Ashcroft rejected our bipartisan work product and Congress ultimately passed an extreme measure, which I opposed. Americans cherish our freedom of speech, the right to due process, and our privacy. The threat of terrorism must not be used to justify powers that undermine America's fundamental Constitutional freedoms.

1.We need a job creation plan that addresses critical changes in our economy. My priorities include:

- Pushing for full funding of the Manufacturing Extension Partnership
- Working to close corporate tax loopholes that encourage corporations to move overseas
- Pushing the Administration to enforce existing trade agreements so American workers can compete on a level playing field
- Strengthening "Buy American" laws to ensure the federal government purchases from American suppliers
- Investing in continuing education programs
- Securing federal funding for economic development projects in western Wisconsin
- Cosponsoring HR 4853, the Women's Business Sustainability Extension Act
- 2. I support enforcement provisions in free trade agreements for labor and environmental protections equivalent to those that apply to commercial provisions. I believe we must be able to have mechanisms in place to ensure labor and environmental protections can be effectively enforced. In nations where labor and environmental laws and law enforcement are of concern, the U.S. must insist on the ability to ensure international labor standards are met and that the environment is protected.
- 3. I supported the PATRIOT Act because it provides law enforcement with the tools needed to protect our country. Yet, it is important that civil liberties of American citizens are protected. As a former prosecutor, I have a deep respect for the judicial process, and as a member of the House Human Rights Caucus, I am dedicated to justice for all people.

Specifically, I am concerned about the invasion of privacy rights of library and bookstore employees and patrons. For this reason, I am a cosponsor of HR 1157, legislation to exempt libraries and bookstores from the PATRIOT Act.

1.In the last 14 years the communities in this District have lost 14,000 manufacturing jobs. It is not our prerogative to tell other countries how their business structure should be operated, that change must come from within. I would, however, support language contained in trade agreements to be used as a bargaining tool in urging companies in other countries to build in better working conditions for employees and make sweatshop labor a thing of the past.

3.I would support the review and renewal of the Patriot Act with a sunset. I believe that this legislation is one of the main reasons that we have not had a single terrorist attack in our country since 2001. The Patriot Act gives our national and foreign intelligence communities the same tools to track down suspected terrorists and it does to tracking down organized crime. The Patriot Act must be kept in check and be scrutinized to make sure it's powers don't cross the line. But again we must not put the civil rights of suspected terrorists ahead of the safety and security of 290 million people.

#### **Biography:**

Bryan Kennedy was born on February 4, 1970 in Hagerstown, Maryland, a blue collar, middle class city in western Maryland. Bryan graduated in the top ten of his high school class and attended Brigham Young University on an academic scholarship. He graduated with a BA in Portuguese and Political Science in 1994. Bryan later completed an MA and a PhD in Romance Languages and Latin American Studies at the University of North Carolina. He is a Professor of Portuguese at UW-Milwaukee. He is married and the father of three children. His wife Heather is a Psychotherapist in private practice.

1.For our state's economy to be successful we must see major healthcare reform and we must have representation in Washington fighting for Wisconsin's fair share. Our employers are having difficulty providing good pay and benefits and still competing in a global marketplace. I propose a healthcare reform in two phases. First, I support the creation of a universal, CATASTROPHIC program. Second, I would place the choice of healthcare providers in the hands of consumers, not employers, a move that fosters greater competition. I will also fight for more federal dollars so that we can lower our state and local tax burden.

- 2.Yes. The current US policy of free trade is forcing many of our small businesses and small manufacturing operations out of business. In order to compete in the global marketplace, more and more "American" corporations are moving their manufacturing overseas. We need a fair trade system that seeks to equalize the playing field. We must demand that all future agreements consider the imbalance in workplace safety standards, environmental regulations and currency manipulation. The rules must be written to allow us to succeed in our own market and to foster true "competition" in the global market.
- 3. There are positive aspects of the Patriot Act. I speak specifically of the ability of state, local and federal law enforcement agencies to share information and to coordinate investigations. I support these measures. I do not, however, believe that the Patriot Act strikes a balance. It gives the federal government over-arching powers to snoop into the private lives of law-abiding citizens. Unlike Mr. Sensenbrenner, the sponsor of the Patriot Act in the House, I will not vote to continue those provisions that invade our privacy and give the government too much power.

#### Biography:

A Republican Member of Congress representing Wisconsin's Fifth Congressional District, Jim Sensenbrenner was first elected to Congress in 1978, after serving ten years in the State Legislature. Congressman Sensenbrenner assumed the chairmanship of the House Committee on the Judiciary in 2001. In Congress, Sensenbrenner has led efforts to fight terrorism, eliminate wasteful government spending, and protect the interests of American taxpayers. Sensenbrenner has regularly been commended by the National Taxpayers Union as one of the most fiscally responsible House Members. He has been married to Cheryl for 27 years, and they have two sons, Frank and Bob.

- 1.It is imperative to improve job opportunities for young people. Too many quality jobs are leaving the nation. Some communities are left crippled after factories and plants close. In response, I authored bi-partisan legislation to allow struggling communities to get back on their feet by revitalizing industrial areas and encouraging local businesses to provide more jobs through regulatory relief and tax breaks. I also support efforts to make tax cuts permanent. The tax cuts increase fairness in the tax code and allow small businesses to keep more of their earnings and hire more workers.
- 2.I support efforts to open foreign markets to American producers, and I support the expansion of trade when it benefits the U.S. Free trade allows American businesses to buy the best quality products and services at the lowest prices, which helps create more American jobs. At the same time, free trade can sometimes place American workers and businesses at a competitive disadvantage with foreign competitors. For this reason, I am strongly opposed to our current policies toward China.
- 3.I carefully evaluate the merits of each trade agreement on a case-by-case basis to ensure that they do not cost American jobs. It is imperative that our nation's leaders act decisively to protect our homeland. As a lead author of the PATRIOT Act, I insisted upon inclusion of a sunset clause in this anti-terrorism legislation to provide Congress the opportunity to review any potential civil rights abuses, enabling us to fully consider the impacts of the legislation. Since the inclusion of these provisions, I have opposed efforts to renew or expand this law prematurely. I look forward to leading a complete and thorough review of the impacts of the PATRIOT Act in the House Judiciary Committee next year.
