# League of Women Voters - Energy

The League of Women Voters of the La Crosse Area has forums on important issues to the citizens of the state and nation at their regular meetings, anything from dental health care to HAVA, Help America Vote Act.

Recently, a Dairyland Power Cooperative guest joined us to talk about current energy and alternative energy. His expertise and focus was coal. Current coal technology has increased efficiency from 35% to 60% and technology has provided better methods for clean stack emissions. However, there are issues with coal extraction and by-products produced from combustion that must be placed in a non-leaking landfill. The take home message is: coal is a part of our energy future but there are ramifications of use.

One alternative energy discussed was anaerobic digestors. Here animal waste is collected, put it in anaerobic digestors where methane gas is produced, the gas is captured and then used to create electricity. DPC is using this technology to produce 750 kw around the clock or enough to provide 7000 homes with electricity. Additional research is necessary to understand this alternative energy source better.

More wind power is a part US energy production but more research is necessary because it can create surges in the power grid that can lead to shut downs.

In fact, no matter what the alternative energy source, solar, Biodiesel (corn, Switchgrass), wind, and/or landfill gas to name a few, research is needed to make them efficient, environmentally friendly and beneficial to the power generator and the user.

## DIALOGUE FOR DEMOCRACY

The Wisconsin Democracy Campaign and the League are co-sponsoring a community discussion on the subject of preserving democracy to today's society. The discussion, "Dialogue for Democracy: Shared Values for Reclaiming Democracy in Wisconsin" will be held Saturday, March 25, 2006 at the Reinhart Center for Ethics, Science and Technology, at Viterbo University from 8:00 a.m. to 12 noon. The speakers will be John Medinger and former legislator David Martin. Please note this is the same day as our Legislative Breakfast!
