## Web Server Statistics for lwvlacrosse.org

The League of Women Voters of California hosts the local League website and has been rolling out new features since we first launched our lwvlacrosse.org website less than 2 years ago. Just announced is a web server statistics service that gives a number of reports on web activity. Now we can track the number of average requests per day, and see what the volume of activity is on the site. Not surprisingly, there was a spike in the number of “hits” around the time of the primary election. The data log, which was initiated on November 11, recorded an average of 48 requests per day. On February 15, the busiest day to date, there were 154 requests for pages. February 10 was the 2nd highest day with 130 requests, followed by February 3 with 114 requests. Some of the pages most often accessed were the candidate forum calendar and the La Crosse mayoral primary candidate responses. There have been over 5,200 total requests for the 107 days statistics have been tracked.

Through keyword searches on various search engines, links from other websites, and references in the La Crosse *Tribune*, an audience beyond our membership is reaching the League website. The League website is becoming another important community resource for information on elections and voting. If you have suggestions for improving the website, please contact Ellen Rosborough or me.
