Immigration: National and State Issues

May Day marches for comprehensive Immigration Policy Reform have just been completed around the country. In Milwaukee, an estimated 60,000 marchers paraded through downtown Milwaukee and to the lakefront, calling for a solution to the country's nagging immigration problems. The marches were part of an effort to push for new laws to better deal with the nation's estimated 12 million illegal immigrants.



Our representatives at the national level, Representative Ron Kind, Senator Herb Kohl and Senator Russ Feingold, will be making decisions on federal legislation that deal with immigration. A representative from each of their offices will be at the May meeting to talk about issues they must consider before voting on changes to federal immigration policy. State legislators will also be present to speak to state issues.

The speakers for this program are: Rebeca Perez, Manager/Regional Coordinator for U.S. Senator Russ Feingold, Brad Pfaff, Senior Policy Advisory for

U.S. Representative Ron Kind, John Medinger, Regional Representative for U. S. Senator Herb Kohl, State Senator Dan Kapanke and Representative Jennifer Shilling.

Keep your eyes open for another program on immigration in June, possibly sponsored by the La Crosse Tribune and the La Crosse LWV.

Check the National League website, www.lwvus.org, for information from the LWVUS Immigration Study Committee. A list of recommended resource materials and Background Papers is available at this site. As this national study ends, Leagues throughout the country will be asked to come to consensus on questions of immigration. The deadline for consensus meetings is December 2007.


State Convention will be next month, June 14 & 15, in Green Bay. There will be some very good speakers and program and quite a variety of decisions to be made by the body of the convention.

Both of the state study groups have proposed additions to our current positions on energy and voters' rights. There are several programs devoted to more information on these topics and then we get to adopt the new positions. In addition, there is a vote on what we will study next, and what we will also focus our activities on for the next year(s).

We have recently received a large grant from the Joyce Foundation which will be used for a campaign to educate the public on campaign finance reform issues. We also may be applying for another grant which could be used in conjunction with our next potential study on Election Administration, to develop a solution to a problem. The money is taking us to places we have not gone before and this is exciting.

The board has been preparing a lot of documents for this convention. In addition to a planned review and update of our bylaws (both organizations) and the annual budget for each organization, we have decided to reorganize the two LWVWI organizations. That meant preparing 4 sets of bylaws and 4 budgets. Plenary sessions this year will not be boring - or maybe they will be more boring - time will tell.

The La Crosse League can have 5 delegates to this convention, plus the President. At this time, there are 3 plus the President, Nancy Hill, possibly going. We have room for at least 2 more. If you have ever thought about learning more about how the organization works at the state level, or want to see how Leaguers can have fun, please think about joining us at convention. AFFORDABLE WHEELS: THE COST OF TRANSPORTATION

Imagine spending almost a quarter of what you earn on travel to and from work. Access to reliable, affordable transportation is an important component in overcoming poverty. Recently, one of Couleecap's program participants stated "Our transportation is starting to get unreliable. We don't have the money for repairs. If anything out of the ordinary happens to our car, our budget falls apart." When budgets fall apart, lives can fall apart. Families already struggling to survive can be severely affected by problems with transportation.

In 2004, the average annual cost of owning and operating a midsize car in the U.S. (assuming 15,000 miles driven per year) was \$8,759. Many low-income families cannot afford to own a car. However, transportation is a critical element for

most people to get to work, go to school, reach needed services, and prosper.



A 2003 Bureau of Transportation Statistics study found that the working poor spend nearly 10% of their income on getting to and from work. This compares to just over 2% for individuals earning \$45,000 or more annually, and 3.9% for all working Americans. For the 66% of the working poor who commuted by private vehicle, the expense of commuting is even more burdensome. Those individuals spent 21% of their income to get to and from work.

Locally, there is bus service in La Crosse County but it does not cover all areas and does not run all hours of the day. For people working second and third shifts, the bus will not get them to and from work. For families needing to make multiple stops (getting to and from work, getting kids to and from daycare, stopping to get groceries, etc.) using the bus is very difficult. Some communities in La Crosse County have cab service, but it can be quite expensive for a family to rely on this type of transportation to meet their daily needs. Cab service is the only public transportation in the counties of Crawford, Monroe, and

Vernon, and only a few communities in each of the counties offer this service.

Count your self lucky if your commute consumes less than 5% of your income.

Couleecap, Inc. is a private non-profit 501(c) 3 charitable organization created in 1966 to fight poverty in the Coulee Region.
