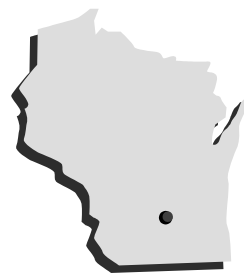
WOW! What a month October has been. There is always something to do as a member of the League of Women Voters. The Unitarian Universalist congregation sponsored a concert and part of the proceeds went to the League to help people get a photo ID for voting, the Hmong Mutual Assistance Association (HMAA) asked that we help with its presidential election, and we still have a lot of work to do on Photo ID's.

In early October, the HMAA Board asked the League to assist in the presidential election for the HMAA. Due to some differences within the community, the HMAA Elections Committee had resigned its post shortly before the scheduled election. As the HMAA by-laws indicate the election must happen in October, the HMAA board asked for our assistance. The LWV Board agreed it is within our mission to assist with an election. League members volunteered to coordinate the election and it was held on October 29th.

Within the next few weeks, the board will be developing a plan for educating the community on obtaining a photo ID for voting purposes. While the ID itself is without a charge, there are underlying costs (such as obtaining a birth certificates) that the public needs to understand. We have received many inquiries about the plan to educate the public regarding photo ID's from community members. It is certainly an opportunity for the LWV to get out the word on the good work we do. As the law and rules continue to change ie: Can student ID's be used? Will the colleges and universities educate the students? Will people over 65 be exempt? it continues to make the

process of educating the public even more complicated.

Please think about what you are able to do to help the League get out the word for the work that needs to be done. I think we are going to need all the help we can get. #### 501(c)3 Status

The WI League of Women Voters has obtained 501(c)3 status. In the past, the organization was classified as a 501(c)4. The most significant outcome of this change in our nonprofit status is that donations to the league are now tax deductible. This status also allows the League a tax exemption on purchases normally subjected to sales tax. The League of Women Voters is still able to engage in nonpartisan lobbying and educational activities under the limits of this classification.

## ***Parental School Choice: What Does It Mean?***

The Wisconsin State Budget expanded the school voucher program in the Milwaukee area and established a voucher program in eastern Racine County. A provision in the budget put in place the automatic creation of school voucher programs in other districts throughout the state when specified criteria were met. The state Senate approved a bill on October 18 to prevent the automatic creation of additional voucher programs without legislative approval. The program December 13 will provide discussion in support and in opposition to the expansion of school voucher programs.

Wisconsin Representative Sondy Pope Roberts is the ranking minority member on the state Education Committee. She is opposed to the creation or expansion of Parental School Choice/ the school voucher program. Mr. Jim Bender is the president of Wisconsin School Choice. He will speak in support of the choice and opportunities that school vouchers provide to parents.
