The papers provided by the national committee are *Common Core Standards and Assessments*, *Early Childhood Education- Equity and Funding*, *Funding and Equity Issues*, *Legislation and Funding for Education of Children Who are Disadvantaged* and *Role of Federal Government in Public Education: Historical Perspectives*.

Approximately 25 people attended a meeting sponsored by the League of Women Voters of the La Crosse Area to discuss the important issue of the Voter ID law that was signed earlier this year and will go into effect in the 2012 election cycle.

People interested in helping others obtain voter identification signed up to help with education, transportation, fundraising, or outreach. Linked to the Voter ID bill, the Unitarian Universalist Fellowship is sponsoring a concert on October 15th, 2011 at 7:30 p.m. at the UU Fellowship. The following information is from the UU Newsletter: "The music will be provided by Fayme Rochelle and the Waxwings, who will offer fine vocals, great up-tempo music, and an opportunity to dance. The cause will be the League of Women Voters' voter registration support campaign, a key initiative at a time when registering and voting have been made more complicated by Wisconsin's new voter ID law.
